

COOPERATIVE AGREEMENT BETWEEN  
GUILDERLAND CENTRAL SCHOOL DISTRICT  
AND

SEPTEMBER 1, 17 THROUGH JUNE 30, 18


1. GUILDERLAND CENTRAL SCHOOL DISTRICT agrees to accept Masters Student's from the Department of Education program, at Massachusetts College of Liberal Arts (MCLA) for internship and practicum experience.
2. Students shall receive no compensation from GUILDERLAND CENTRAL SCHOOL DISTRICT and are in no way to be deemed employecs of GUILDERLAND CENTRAL SCHOOL DISTRICT Students shall be required to secure student liability insurance in the amount of \$1,000,000/\$3,000,000 with such companies as the College shall reasonably require.
3. GUILDERLAND CENTRAL SCHOOL DISTRICT shall:
  - a. Provide a variety of learning experiences to the interns appropriate to the setting
  - b. In coordination with the internship coordinator of the MCLA program, Dana Kapp, plan an internship program that meets the needs of the facility and the objectives of the interns
  - c. Designate an appropriately credentialed professional to supervise the interns
  - d. Retain full and final responsibility for supervision of students
  - e. Review each student's performance, in writing, during the final week of each semester
  - f. Provide ongoing opportunities for formal and informal verbal feedback to the students and the internship coordinator regarding student performance
4. The MCLA Department shall:
  - a. provide all coordination of intern participation at GUILDERLAND CENTRAL SCHOOL DISTRICT
  - b. designate a faculty member (the internship coordinator) to coordinate intern placement, communicate with representatives of GUILDERLAND CENTRAL SCHOOL DISTRICT supervise interns and insure that they are provided a meaningful learning experience
  - c. communicate on a regular basis with the supervisor designated by GUILDERLAND CENTRAL SCHOOL DISTRICT
  - d. will require that its students to dress according to the policies of GUILDERLAND CENTRAL SCHOOL DISTRICT and conduct themselves according to professional standards
5. MCLA will indemnify and hold GUILDERLAND CENTRAL SCHOOL DISTRICT harmless from and against all lawsuits or claims which result from the negligent activity of its students, faculty or employees while on the premises of GUILDERLAND CENTRAL SCHOOL DISTRICT in connection with this cooperative agreement. GUILDERLAND CENTRAL SCHOOL DISTRICT shall similarly hold MCLA harmless from and against all lawsuits or claims which result from the negligent activity of GUILDERLAND CENTRAL SCHOOL DISTRICT employees.

6. This agreement shall be for the period commencing September 1, 2017 and ending June 30, 2018. All activities pursuant to this agreement shall terminate unless the effective period of this agreement be extended in writing.
